Motion 2:

5. President Report

The IRB team was deployed to the south coast to assist with evacuations along the coastline during the bushfires, the callout team was deployed on several incidents



including a boating tragedy off Bulli Point (Peggies), our patrols were busy with multiple rescues requiring ambulance assistance and then we had to organise shutting down the club with the uncertainty of the COVID-19 virus. These incidents highlighted to me how well the club united, not only as a surf club but now as an accredited Emergency Service Agency.

I must thank our executive committee: Jeff Body, Chris Adams, Kim Adams, Kim Shipton, Nigel Rowe, Jason Cross and Jen Norbury. In addition thanks must also go to our active Role Position Holders Alison Montgomery, Michelle Emmett, Roy Wakelin-King, Tor Westley-Wise, and Julie Turner. Together we ensure our club runs smoothly. We all appreciate this would not be possible without all the members who contribute, from Patrol Captains to Callout Team Members, from Nipper Age Managers to our Water Safety Team, COVID Cleaners to Gear Stewards, Bar Staff to Gym Managers, Registrar to Clothing Coordinator, Coaches and BBQ helpers. It is all of us that make Thirroul Surf Club the great club it is.

In our competition arena our Masters female team celebrated 40 Years of Women in Surf Life Saving by medalling in both individual and team events. This is a first in our club's history so onto the honours board you go Michelle Emmett, Tor Westley-Wise and Di Gillett. Well done.

Ross Taylor represented us well as always, winning 4 gold medals and thus winning the Illawarra Branch Masters Competitor of the Year Award so qualifying for state nomination.

Our masters as a whole team excelled with 15 out of 16 competitors medalling which resulted in our club achieving 7th in the club championship point score. Our best placing ever!!!

So, without knowing it these competitors are inspiring our next generation of active members including our junior, youth and open competitors who did very well in a tough competition. Jayden Beaumont did exceptionally well, being selected for the NSW Junior Development Academy. Elise and Jayden Beaumont, Jack Wilson, Georgia Petty and Meg Fox were selected for our Illawarra Team. It would have been even a better year competition-wise but COVID-19 cancelled the Branch Titles that we were hosting. It's the first time they have been cancelled ever!!!. Jason Cross and Jeff Wall had done a lot of pre-planning for the carnival so should be commended for their work.

This follows into our in-house competitions where we were required to think outside the square to continue training during COVID-19 by completing set courses individually with a monthly timed winner. These activities were beneficial both physically and mentally for us during the COVID-19 restrictions. Away from competition we have tried to develop towards the future with our succession plan geared at keeping our youth and nipper members. Jennifer Norbury and her team have done a great job with strong junior numbers in sometimes trying circumstances on Thirroul Beach, while our youth were involved in Illawarra Branch outings to Jamberoo Recreation Park, Laser

Tag and Flipout. Our goal is to keep our teenagers involved, not only for the club but for the kids and parents, as we all know the "surf club" environment is a great place for teenagers to be.

Patrol teams also completed 41 first aid treatments which was mainly made up of marine stings and cuts/abrasions.

We welcomed a number of new patrolling members that have gained their Bronze Medallion or Surf Rescue Certificates throughout the season which will be a huge boost to our patrols and will assist us with patrolling numbers for next season ensuring we keep a safe and enjoyable environment for everyone.







8. Inflatable Rescue Boats

The 2019/2020 season of patrols, education and emergency call outs has kept our IRB motors running smoothly and crews up to date and fluent in their rescue skills and surf knowledge.

Congratulations to the members that advanced their skills by obtaining their crewman certificate and/or drivers silver medallion. Each member should be proud of the skills and qualifications they have earned as these play an important role in keeping our beaches, members and

community safe. Our dedicated patrolling members utilised the IRBs to assist in rescues, preventions, event water safety and emergency after hours call outs in the area.

During the devastating 2019 bushfires four members of our emergency response team responded to an emergency call to assist the Sussex Inlet and surrounding communities with our IRB and first aid equipment. These members were tasked to provide assistance where needed as the fires continued to threaten the small towns. Our members worked in collaboration with other IRB crews from the Illawarra and local Sussex Inlet clubs. Through the extreme hard work of the RFS the fires were kept under control and the IRB crews were able to return home safe after a few days of service.

On the long weekend in June, Thirroul call out team members answered the call for our IRBs and crew members to assist other emergency services in a major search and rescue operation after a boat capsized off Bulli. Our lifesavers teamed up with over 65 other Illawarra lifesavers to conduct the search for a missing person. This was possibly one of the biggest Surf Lifesaving operations in recent history with the number of members and assets involved from many Illawarra clubs.

Due to COVID-19, the IRB racing season did not go ahead as planned and was pushed back with the possibility to run at the end of August 2020. The racing calendar was condensed to be able to run before the start of the new season in September. The proposed calendar will consist of one round, state IRB titles and a possibility of the Australian IRB championships.

I would like to congratulate all members who utilise our IRBs throughout the season for displaying outstanding teamwork rescue skills and professionalism.

11. Surf Sports

A promising 2019/20 season of training and competition opened with the arrival of Jason Cross, Sports Surf Co-ordinator and current Canadian National SLS coach. Jason enhanced his early lifeguard experience in Nova Scotia with stints as a professional Lifeguard with WCC and Gold Coast Councils in the 1990's. He went on to represent and captain Canada at six World Championships. His myriad of national titles includes nineteen individual ironman wins. He was also a member of the Thirroul winning surf team, board relay and third in the ironman the NSW State Masters in 2020. The training programme encompassed board, ski and surf swim sessions, complemented with a weekly sprint session on the grass.

In the early Sydney Water carnivals during November the nipper, youth, open and masters recorded some pleasing results with a number of victories in the surf and on the sand. This resulted in the following members gaining selection for the Interbranch team for the annual event hosted by Bulli in 2019: Jayden Beaumont, Jack Wilson, Georgia Petty, Elise Beaumont and Meghan Fox. All were successful in either individual or team events.

An indication of the surf skills and depth of the club's youth team competitors saw nine of them successfully employed onto local council professional lifeguard rosters for the summer of 2019/20. The pinnacle for the competition year was to see Thirroul host the 2020 branch carnival. The highly experienced team of club members assembled under Jason's direction created a template that targeted a revitalisation of this annual event. Unfortunately, an East Coast Low weather pattern in successive weeks foiled the plan and the event was abandoned due to huge seas and a sand less beach. Their efforts have been rewarded with the Illawarra Branch SLS executive requesting us to host it again in 2020/21.

A few weeks before the state titles on the Central Coast at Swansea Belmont, as we now know, the COVID-19 virus was heading for pandemic proportions worldwide leaving the state titles as the last competition for the year. Subsequently all national and international SLS competitions were suspended indefinitely.

Four nippers travelled up the highway to Swansea, three for their first go in the "big time". Jett Blue, James and Lucas Meades competed well and Zoe Wilson, an old hand also did well in her age group. The youth and our very young open competitors competed well but fewer numbers restricted their ability to contest team events.

Under 14 Jack Wilson had shown form all year on the paddle board, especially at Interbranch, that indicated he could be a medal contender at the state and Australian titles. After qualifying comfortably for the final Jack led to the first turning can but in the usual melee around the cans at this level of competition, he lost his position to finish disappointedly near the rear. Dylan Gillett qualified for the U19 board final in a race where any of the sixteen had a chance of victory. His seventh, in a blanket finish, confirmed his status as a young, preeminent board paddler.

Meg, Jett, Jake, Eryn, Kayde and Sienna went around the tins numerous times but didn't manage any finals. It is tough at the top!

And so to the Masters with a capital "M". This group meet and train in large numbers on a Saturday morning sometimes numbering forty starters. Although competitive numbers have dwindled in recent years sixteen members contested the state titles. Fifteen of them won medals in individual and/or team events.

We contested one beach event yet finished seventh on the points table easily eclipsing the strong Sydney clubs in the ratio of medals won/to number of competitors. The high point saw Michelle Emmett, Di Gillett and Tor Westley-Wise bring home a bronze in the 150 yo female team board relay. A first ever for women in Masters competition for Thirroul. Ross Taylor later was awarded the Illawarra Branch Master of the year for his efforts.

In a final summation, although the club is a sum of its many parts, this effort from the masters, many with no background in surf competition, is indicative of the strength of our beach patrols. Strong, efficient patrols are defined by a comprehensive ability to navigate a rescue board through the inshore break and effect a rescue. Thirroul dominated the board events in all of the contested age groups at the State Masters Titles.

15. Finance Report

The committee decided to upgrade the subscription for MYOB to the cloud version. This will allow easier transfer of files at handover of the position in the future. It also allows accountants to have easy access to financial records for auditing purposes.



Attached to this report is the Club's Financial Report for 30th April 2020 produced by HLB Mann Judd.

Income from registrations remained on par with the previous year being 26.3% of income sources.

In November 2019, the club received a grant of \$15,000 from IMB for the purchase of a new ATV, total cost being \$18,844.20. The old ATV was sold for \$7500.00.

Unfortunately, due to inclement weather, the scheduled Branch Competition of which our club was the host were unable to be held meaning some loss of anticipated revenue.

During 2019-2020, the hiring of the function centre continued to be a great source of income to the club bringing in 23.6% of our income and the club acknowledges the effort that our Function Coordinator, Alison Montgomery, contributes to the successful hiring of the space, in particular as a wedding function centre, even with cancellation due to COVID-19 restrictions which affected April bookings. The real effect on loss on income from the function centre due to COVID-19 will be felt more in the 2020-21 figures with many functions not going ahead in recent months. Fortunately, at this stage many have been postponed rather than cancelled.

Income from junior activities total is approximately 12% of our income. The club purchased 10 new nipper boards as current stock was showing wear and tear, along with 2 Junior Surf ski boards to encourage diversity in our juniors.

Moving forward, the committee has given approval for purchase of a new IRB - \$15,455.

Thank you for the opportunity to be involved in the club in this capacity.

NOTES TO AND FORMING PART OF THE FINANCIAL STATEMENTS AS AT 30 APRIL 2020

NOTE 1: STATEMENT OF SIGNIFICANT ACCOUNTING POLICIES

This financial report is a special purpose financial report prepared in order to satisfy the financial reporting requirements of the Associations Incorporation Act NSW and the Australian Charities and Not-for-Profits Commission Act 2012 The committee has determined that the association is not a reporting entity.

The financial report has been prepared on an accruals basis and is based on historic costs and does not take into account changing money values or, except where specifically stated, current valuations of non-current assets.

The following material accounting policies which are consistent with the previous period, unless otherwise stated, have been adopted in the preparation of this financial report.

Revenue

Donations and bequests are recognised as revenue when received, unless they are designated for a specific purpose, where they are carried forward as prepaid income on the balance sheet.

Interest revenue and distribution income from investments are recognised on a proportional basis taking into account the Interest rates applicable to the financial assets.

Revenue from the rendering of a service is recognised upon the delivery of the service to the customers.

All revenue is stated net of the amount of goods and services tax (GST).

Inventories

Inventories are measured at the lower of cost and current replacement cost.

Inventories acquired at no cost, or for nominal consideration are valued at the current replacement cost as at the date of acquisition.

Income Tax

The association is, for income tax purposes, a Charitable Institution. Its income is therefore, exempt from income tax under Section 50.1 of the *Income Tax Assessment Act 1997*.

Fixed Assets

Leasehold improvements and office equipment are carried at cost less any accumulated depreciation where applicable.

The depreciable amount of all fixed assets are depreciated over the useful lives of the assets to the association commencing from the time the asset is held ready for use. Leasehold improvements are amortised over the shorter of either the unexpired period of the lease or the estimated useful lives of the improvements.

Comparative Figures

Where required by Accounting Standards, comparative figures have been adjusted to conform with changes in presentation of the current financial year.

Qualified Opinion

I have audited the financial report of Thirroul Surf Life Saving Club Incorporated ("the Entity"), which comprises the balance sheet as at 30 April 2020, the income statement, and notes to the financial statements, including a summary of significant accounting policies, and the declaration by the Management Committee.

In my opinion, except for the effects of the matter described in the Basis for Qualified Opinion section, the accompanying financial report of the Entity is in accordance with Division 60 of the Australian Charities and Not-for-Profits Commission Act 2012, including:

a) giving a true and fair view of the Entity's financial position as at 30 April 2020 and of its financial performance for the year then ended; and

b) complying with Australian Accounting Standards to the extent described in Note 1 and Division 60 of the Australian Charities and Not-for-profits Commission Regulation 2013.

Basis of Qualified Opinion

As is common for organisations of this type, it is not practicable to maintain an effective system of internal control over donations, subscriptions and other fund raising activities until their initial entry on the accounting records. Accordingly, our audit in relation to fundraising was limited to the amounts recorded.

The Entity's inventories are carried in the statement of financial position at \$24,106. This is a Committee's valuation based on a report prepared by the Entity. I was unable to obtain sufficient appropriate audit evidence about the balance of inventory at 30 April 2020 because we did not attend the stock take.

I conducted my audit in accordance with Australian Auditing Standards. My responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Report section of my report. I am independent of the Entity in accordance with the auditor independence requirements of the Accounting Professional and Ethical Standards Board's APES 110 Code of Ethics for Professional Accountants ("the Code") that are relevant to my audit of the financial report in Australia. I have also fulfilled my other ethical responsibilities in accordance with the Code.

I confirm that the independence declaration required by Division 60 of the Australian Charities and Not-for-profits Commission Act 2012, which has been given to the Management Committee, would be in the same terms if given as at the time of this auditor's report.

I believe that the audit evidence I have obtained is sufficient and appropriate to provide a basis for my opinion.

Basis of Accounting

Without modifying our opinion, we draw attention to Note 1 to the financial report, which describes the basis of accounting. The financial report has been prepared to assist Thirroul Surf Life Saving Club Inc to meet the requirements of the Associations incorporation Act NSW and the Charitable Fundraising Act for the purpose of fulfilling the committee's financial reporting responsibilities. As a result, the financial report may not be suitable for another purpose.

Responsibilities of Management Committee for the Financial Report

Management is responsible for the preparation of the special purpose financial report that gives a true and fair view in accordance with the relevant Australian Accounting Standards in accordance with the Australian Charities and Not-for Profits Commission Regulations 2013 and the Australian Charities and Not-for-profits Commission Act 2012 and for such internal control as management determines is necessary to enable the preparation of the financial report that is free from material misstatement, whether due to fraud or error.

In preparing the special purpose financial report, management is responsible for assessing the Entity's ability to continue as a going concern, disclosing, as applicable, matters related to going concern and using the going concern basis of accounting unless management either intend to flouidate the Entity or to cease operations, or have no realistic alternative but to do so.
